# TRIGGER POINT DRY NEEDLING COURSE ACCREDITATION

## Introduction

Thank you for seeking Australian Traditional-Medicine Society (ATMS) accreditation of your course. Please ensure that you have read the ATMS Recognised Provider of Natural Medicine Training or Education Application Form and the ATMS Minimum Education Standards for Trigger Point Dry Needling prior to filling out this document.

This form is only for your institution's course(s) that relate to the ATMS modality "Trigger Point Dry Needling". An Application form needs to be filled out for every course that you are seeking ATMS accreditation for.

It is of note that ATMS Accredited (Practitioner) Membership for Trigger Point Dry Needling is at a Post-Graduate level and therefore pre-requisite requirements exist. All graduating students of an ATMS Accredited Trigger Point Dry Needling course must also demonstrate eligibility, if not compliance, with the pre-requisite requirements at the time of applying for practitioner accreditation which includes holding an appropriate qualification and membership with ATMS in any of the following modalities.

- ▶ Remedial Massage (minimum of an Advanced Diploma level qualification or equivalent)
- ▶ Traditional Chinese Massage (minimum of Advanced Diploma level qualification or equivalent)
- ▶ Chiropractic (minimum of Bachelor Degree qualification or equivalent)

The following terms are used in this form. It is essential that you understand them and their definitions when answering the relevant questions. These definitions are for ATMS purposes, and the same words may have a different meaning when used by other agencies or organisations. So to avoid confusion, please take the time to read the definitions carefully.

**Course Nominal Duration:** "Course Nominal Duration" is the length of time, on average, it takes a student with no recognised prior learning to satisfy the requirements of the qualification. Home study is included.

**Face to Face Practical Study:** Face to Face Practical Study is only study which in the opinion of ATMS is undertaken in the physical presence of the lecturer, trainer or presenter. It excludes all forms of study delivered remotely by electronic and similar modes, and including even those that allow for real time interaction between lecturer/students and students/students. It also excludes all home study, prior reading/study for lessons, research for assignments, unless done in the physical presence of the subject lecturer, trainer or presenter etc.
