The Australian Traditional-Medicine Society (ATMS) was founded in 1984 as a not-for-profit company incorporated with the Australian Securities and Investments Commission (ABN 46 002 844 233).

ATMS promotes and represents professional practitioners of natural medicine, who are encouraged to pursue the highest ideals of professionalism in their natural medicine education and practice.

General Academic Eligibility

Accredited membership is the only category suitable for a practitioner, and entitles the member to the full range of professional benefits.

To meet the academic qualifications required by ATMS, an applicant must have successfully completed study in a course approved by ATMS; or successfully completed a non approved course which in the opinion of ATMS is of an equivalent standard to the applicable ATMS academic criteria.

Overseas Qualifications

ATMS does accept overseas qualifications providing that the course is of an equivalent standard to the applicable ATMS academic criteria. Any documentation or qualifications that are in a language other than English need to be officially translated.

It is of note that Health Funds generally do not accept overseas qualifications, or may require further documentation in addition to what is required for membership of ATMS. Please contact the ATMS Office for more information.

As at April 2017, ATMS had 11,000 financial members, representing about 65% of all natural medicine practitioners nationally.

ATMS has three categories of membership:

- Accredited member
- Student member
- Associate member

Other Eligibility Criteria

The above eligibility criteria are the primary specific criteria at the time of publication. In addition an applicant must be at least 18 years of age and of good character. ATMS may amend its membership eligibility criteria at any time, and that criteria will be applied regardless of whether or not it is published in the Membership Information and Application Form.

How Long Does Accredited Member Processing Take?

For successful applicants who have completed an ATMS approved course, it may take up to 14 days for receipt of confirmation of membership.

For applicants who did not complete an ATMS approved course, the application may need to be assessed by the Academic Review Committee which meets on a regular basis. The Committee will not assess an application unless full documentation is attached.

Checklist of Documents to Submit

Applicants who have completed an ATMS approved course must submit the following documents with their application:

- A copy of your education qualification that has been certified by a Justice of the Peace (please do not send the original college issued award).
- A copy of the academic transcript that has been certified by a Justice of the Peace showing details of the subjects and hours of study per subject (please do not send original college issued document).
- A list of subjects, within the qualifications used for joining ATMS, that were undertaken entirely by distance education or other off-campus study.
- A list of subjects, within the qualifications used for joining ATMS, which were obtained through Recognition of Prior Learning (RPL). All supporting evidence of the prior training, skills and knowledge used to gain the RPL must also be submitted.
- If you have a different name on your education qualification, legal proof of name change.
- Passport size photograph.
- If born outside of Australia or New Zealand, proof of permission to work in Australia.
- A copy of your current Senior First Aid Certificate.
- If you already have Professional Indemnity Insurance, please send a copy of your insurance policy with your application. (For most applicants this will be arranged after gaining membership with ATMS.)

- If you already have health fund provider status, please include your provider numbers with your application.
- If you are applying for accreditation in Osteopathy, Chiropractic, Acupuncture and/or Chinese Herbal Medicine, proof of current practicing registration with the relevant National Registration Board.
- If your qualifications are more than 5 years old, please submit evidence of professional clinical experience, as well as evidence of continuing education.
- Credit card details, Cheque or Money Order.

For applicants who did not complete an ATMS approved course, the preceding documents must be submitted where relevant) as well as the following:

- Evidence of the number of supervised clinical training hours undertaken during or after the course and the minimum number of consultations as the primary consulting practitioner during this period. Please note that the health funds generally do not accept supervised clinical training completed after the course.
- Evidence of the number of hours of face to face training as a part of your course.
- The teaching institution prospectus and course curriculum.

In all cases the ATMS reserves the right to request additional documentation as required. Failure to submit requested documents may result in rejection of the application.

Membership Fees

Membership fees are based on the financial year. To join ATMS between July and December (full year), the membership fee is \$280. To join ATMS between January and June (half year) is \$165. All memberships expire on the 30th June each year.

The fees listed above includes the administrative fee, GST and is correct at the time of publication, but is subject to change without notice. For applicants who do not proceed with membership, the administrative fee will be forfeited.

Student Member Upgrade Applications

Upgrade applications for an ATMS student member to be an accredited member may be made by completing the Application at the end of this form. Please see the "Checklist of Documents to Submit for Accredited Membership" for the required additional documentation. (You do not need to provide another photo if you have already provided ATMS with a photo when you applied for student membership.)

Please contact the ATMS Office to determine the cost to Upgrade, as half or full year fees may apply.

ATMS Membership Directory

Accredited members' details are made available to the public in an online directory as part of the ATMS website www.atms.com.au maintained by ATMS. This is an excellent source of free advertising for Accredited members which utilises a user friendly search engine. The website directory is updated and lists the name, membership number, clinic addresses, clinic telephone number and disciplines of Accredited members. As well as listing practice details, members may include a clinic email address and a link to their own website.

If an Accredited member wishes to have their details included in the directory, please tick Yes to this question on the application form. Unfortunately members cannot have the choice of inclusion of one clinic address and not another. A Yes tick indicates that all clinic addresses on file will be included in the directory.



Health Funds

ATMS is a 'professional organisation' within the meaning of section 10 of the Private Health Insurance Accreditation Rules 2011. This potentially allows ATMS accredited members to be recognised as approved providers by the various private health funds.

Approved health fund provider status is, however, subject to each individual health fund's requirements. Consequently membership of ATMS does not automatically qualify a practitioner to be a recognised/ approved provider with all health funds. Please also note that several health funds do not recognise courses done substantially by distance education, or qualifications obtained overseas.

To ensure a faster assessment and processing of any eligible health fund provider status after your membership application has been processed, please ensure you submit the following with your membership application:

- Completed ATMS Health Fund Declaration Form (available on the ATMS website)
- Evidence that you meet the individual health fund education criteria. The individual health fund criteria is available on the ATMS website. Please note that the evidence required by the health funds for assessment may be in addition to the documents already provided by your college.
- If you already have health fund provider status, please include your provider numbers and the health funds that you are registered with when submitting your application.

Additional requirements for recognition as a provider by health funds include:

First Aid Certificate

Accredited members are required to have a current Provide First Aid (also known as Senior First Aid, Workplace Level 2 or Apply First Aid) certificate. A copy of the certificate must be sent with the application form.

Professional Indemnity Insurance

Accredited members are required to have current professional indemnity insurance. This is also a requirement for health fund provider status. The ATMS Professional Indemnity Insurance Policy Scheme allows members entry to a high quality insurance policy at a very competitive rate.

Details of the ATMS Professional Indemnity Insurance Policy Scheme will be sent to you with your new member pack. You must be accepted as an ATMS Accredited member before being allowed entry into the scheme.

Please note that some health funds require a certain minimum level of cover. Please refer to the health fund individual Terms and Conditions for further information.

Should you already have Professional Indemnity Insurance prior to joining ATMS, please send a copy of your policy with your application form.

Continuing Professional Education

All Accredited members must fully participate in the ATMS Continuing Professional Education Program and maintain evidence of their Continuing Professional Education activities. Evidence of Continuing Professional Education activities must be provided if requested by ATMS.

Details of the ATMS Continuing Professional Education Program will be sent to you with your new member pack, and are also available on the ATMS website. It is also a requirement of health funds that recognised practitioners undertake ongoing, continuing education activities.

Health Fund Rebates

A full list of health funds which rebate on specific modalities is placed on the ATMS website. Updated information on health fund changes is also published in both the Journal of the Australian Traditional Medicine Society as well as on the ATMS website.

For health funds to rebate on the services of Accredited members, it is important that a proper invoice be issued to patients. The information which must be included on an invoice is also listed on the ATMS website.

It is ATMS policy that only Accredited members issue their own invoice. An Accredited member must never allow another practitioner, student or staff member to use their provider details, as this constitutes health fund fraud. Misrepresenting the service(s) provided on the invoice also constitutes health fund fraud. Health fund fraud is a criminal offence which may involve a police investigation and expulsion from the ATMS Register of Members.



Professional Conduct

It is a condition of ATMS membership that the professional conduct of members is bound by the ATMS Constitution, ATMS Code of Conduct, and official ATMS policies as determined from time to time by the ATMS Executive.

Copies of these documents are available on our website.

Complaints

A member of the public, or another practitioner, may lodge a formal complaint against a member for a breach of the Code of Conduct.

A complaint against a member is deliberated upon by the ATMS Complaints Committee. Should the complaint be upheld, a range of sanctions can be imposed depending on the severity of the misconduct. One sanction open to the Board of Directors is expulsion of the member from the Register of Members. Complaints which involve a serious allegation may be referred to the Police or other relevant Government Agency for investigation.

ATMS Official Policies

The following are a summary of the ATMS policies which have been determined by the ATMS Executive. All ATMS members must comply with the ATMS policies. For further information of our policies, please refer to our website www.atms.com.au.

Internal Examinations

As the practice of natural medicine does not in any of its forms require an internal examination, any internal examination by a member, even if the patient submits, is regarded as indecent assault which is a criminal offence.

Breast Massage

It is the ATMS policy that members do not massage the mammary glands of patients, and that only professional techniques be applied to surrounding tissue.

Ingestion of Essential Oils

Suitably qualified practitioners may prescribe the ingestion of essential oils providing the essential oils are combined with other non-essential oil ingredients which are included for therapeutic use and the product is listed or registered on the TGA ARTG. The prescribed level of essential oil should be regarded as safe. That is the level of prescribed oil should be less than the maximum levels established by the Australian National Drugs and Poisons Scheduling Committee.

Use of the Title 'Doctor'

ATMS requires practitioners (who are not registered medical practitioners) who choose to adopt the title "Dr" in advertising, whether or not they hold a Doctorate or PhD, make it clear that they do not hold registration as a medical practitioner. In advertising the title of "Doctor" or "Dr" the full title of the doctoral qualification must be provided whenever the title is used. For example: Doctor Mary Jones (Doctor of Philosophy).

Continuing Professional Education Program

It is ATMS policy that all Accredited members must fully participate in its CPE program. Details of the CPE program are found on the ATMS website at www.atms.com.au.

Accredited members' CPE activities are subject to a yearly audit. If audited, a member must provide satisfactory evidence that applicable Continuing Professional Education activities were undertaken.

Work Health and Safety

It is the ATMS policy that members will comply with all the applicable Work Health and Safety requirements in their practice.

Health Fund Receipts

It is ATMS policy that under no circumstances may a student, staff member or another practitioner use someone else's membership number for purposes of issuing receipts for health fund rebate. All information provided on a receipt must be completely true and correct.

Patient Confidentiality

Patient confidentiality is an essential requirement of healthcare practice. Wrongful disclosure of personal information in respect to a patient by a member of the Society, or a member of his or her staff, is a breach of the Society's Code of Conduct and its Constitution. The Executive will give serious consideration to the termination of the membership of the Society of any member who directly or indirectly wrongly discloses such information. Members are required to abide by Privacy Law. Information to help members comply with their Privacy obligations is available on the ATMS website.

Telephone and Internet Consultations

While face-to-face consultations are preferred, online audio-visual consultations can provide a more convenient and accessible healthcare delivery without compromising patient safety. Only financial accredited ATMS members with qualifications in Counselling, Herbal Medicine, Homoeopathy, Naturopathy and Nutrition can provide online audio-visual consultations. ATMS Student members must not practice or perform consultations. For guidance, please refer to ATMS' Online Audio-Visual Consultation Policy.
